# 1. TRUST NAME AND OFFICE

The Trust shall be called VIVEKANANDA EDUCATIONAL AND CHARITABLE TRUST. The Office of the Trust shall be situated at No 59/8, Shiva sakthi Nagar , Pollachi Road, Ellis Nagar post, Dharapuram TK, Pin 638657. or at such other place / places as decided by Trustees from time to time.

#### 2. PUBLIC CHARITABLE TRUST


The Trust shall be a "Public Charitable" Trust.

#### TRUST FUND

- a. The "Trust Fund", wherever referred to in these presents, shall mean and include the amount of Rs. 15000 /- (Rupees Fifteen Thousand only) settled by the Settlor and trustees in favor of the Trust and other money or funds and assets coming into and becoming part of the Trust Fund in whatsoever manner including those borrowed or raised by the Trustees in exercise of powers under this Trust Deed such as donations, contributions, interestfree and other loans, accumulations and accretions, cash, debentures and other securities of Government / Public Sector Companies, other securities of limited companies, other securities including Government Securities and Bonds, gifts and settlements of all properties whatsoever, all other movable properties (whether agricultural or non-agricultural and their leases and tenancies) which may hereafter be paid to, received or acquired or gifted by, settled upon made or transferred to or taken by the Trustees and investments for the time being representing the same and capital accretion/s that may take place during continuance of this Trust and their income, profits, dividends and interest. The Trust Fund shall also include donations, loans (interest-free or otherwise) and other contributions received in cash or in kind from other companies, establishments, persons and other commercial organizations.
- b. "Income" shall include the loss incurred or suffered by the Trustees in carrying out or undertaking or engaging in any activity for income. Wherever this Deed has stipulated that the Trustees shall receive, hold and distribute the income of the Trust Fund for and on behalf of and for the benefit of the Beneficiaries, it shall always be deemed to include such loss.



#### 4. BENEFICIARIES

- (d) All such accumulations of income to be held in trust by the Trustees for the benefit of the Beneficiaries; and

The Trust is at liberty to borrow or otherwise raise money from any person upon such terms and conditions as the Trustees may deem fit, the purposes of the Trust.

The Trust Property shall vest in the Trustees and the Trustees shall hold the Trust Property and/or the accumulation, additions, accretions thereto in trust for the benefit of Beneficiaries, subject to the provisions of this Deed of Trust.

# **OBJECTS AND PURPOSES OF TRUST**

All the activities of the Trust and the benefits and results thereof can be made available to the Public at large.

The benefits of the activities of the Trust shall ensure to the entire public in India without distinction with regard to caste, community, religion or creed.

All the objects of the Trust are charitable and shall not be motivated for any profit.

#### **OBJECTS**

- a) To establish, take over, acquire, maintain, run and manage schools, colleges, and other educational institutions and all related facilities including hostels, libraries, resource centres, IT training rooms, laboratories, gymnasiums, swimming pools, technical courses, nontechnical courses etc., for imparting general, technical and scientific knowledge in the name of the trust.
- b) To provide education to the general public through all permitted medium such as regular stream, distance education, VSAT based education and so on.
- To encourage and promote learning in literature, arts, medicine, science, agricultural crafts, history, technology, and technical education, including Information Technology and other areas of knowledge.
- d) To promote philanthropy in education among socially conscious public, corporate and funding agencies.
- e) To award scholarships, grants, assistance, and stipends, in India to deserving students to enable them to pursue their education.
- To institute and award prizes for high proficiency and excellence for outstanding students and teachers.
- g) To conduct training programs for teachers and students on good practices in teaching and education, value education, improving learning impact among students, personality development and life skills.
- h) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- To establish research and training centers for the furtherance of education/learning in it's various fields and branches.
- To arrange literary associations, educational conferences, tours, seminars, lectures, and debates, for the benefit of students and teachers

- n) To function as a Non-communal Trust and as a secular organisation.
- n) To confer title on eminent personality in the field of science, education, literature, etc.


# Other Objectives and Activities are as follows:

- To do such all other lawful activities as the trust considers conductive to the attainment of all or any of the above objectives.

#### 8. TERM OF OFFICE OF THE TRUSTEES

The First trustees shall hold office till their lifetime or resignation.

# 9. VACANCIES

Any vacancy among the Members of the Board of Trustees, either due to resignation or death, may be filled by the Managing Trustee / other Trustees as specified above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

#### 10. TERMINATION OF OFFICE OF THE TRUSTEES

- (a) Trustee shall cease to hold office:
  - i) If he dies,
  - ii) If he resigns,
  - iii) If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
  - iv) If he is found to have acted against the interest of the Trust,
  - v) The Board of Trustees by Passing special resolution. (Not less than 2/3 of Members present in the board of trustees meeting) specified in Para (4) above that his continuation in the Office is against the interest of the Trust. or if he is found to have acted against the interest of the Trust

vi) Upon expiry of the period up to which the Board of Trustees have nominated the trustee.

# 11.MEETING AND PROCEEDINGS OF THE TRUSTEES

The Trustees shall ordinarily meet once in 3 months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

#### 12.NOTICE

7 Days Notice shall ordinarily be given in writing for a meeting of Board of Trustees.

#### 13.QUORUM & MINUTES

The Quorum for the Meeting of the Board of Trustees shall be 1/3 of total trustees. The meeting may be adjourned to such other date as may be agreed upon, for want of quorum.

A minute book shall be kept by the Secretary. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the Chairman of the Meeting.

#### 14.VOTING

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The Chairman of the meeting shall have a casting vote in the event of equality of votes, in addition to his own.

#### 15. POWERS, FUNCTIONS AND DUTIES OF THE BOARD OF TRUSTEES

(a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the Trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

(b) In particular and without prejudice to the generality of the foregoing the Trustees shall for the purposes of this trust have the following powers, duties and functions:

- i. To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
- ii. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably in lease land and own land.
- iii. To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- iv. The funds of the trust shall be invested in accordance with the provisions of the Income Tax Act or as may be required as per regulations made under the Income Tax Act as the case may be.
- v. To raise loans, to receive monies, securities or other movable property on behalf of the Trust.
- vi. To raise funds by way of loan from any bank on behalf of the trust.
- vii. To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- viii. To award scholarship and make donations calculated to promote the objects of the Trust.
- ix. To enter into contracts, or engagements on behalf of the Trust.
- To consider such proposals submitted by Sub -committee appointed by this X. trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- xi. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
- xii. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- xiii. To sell, transfer or otherwise dispose of any immovable property of the trust provided all the Trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- To appoint a Committee/Committees of management for such terms and xiv. with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- XV. To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- xvi. To delegate to the Managing Trustees or any appointed committee such powers, duties and functions as are vested in the Trustees.

xvii. To frame Bye-Laws and such other regulations as are required for achieving

xviii. Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely:

- a. All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
- b. Pay lease rent for those assets taken on lease.
- c. The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
- d. The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
- e. The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the Trustees shall think fit.
- f. Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the Trustees in the carrying out of this trust.
- g. Cost and expenses of keeping the trust property in good condition.
- h. Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- i. The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- j. All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.

After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of Trustees.

#### 16. BANK ACCOUNT

(i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of Trust, such accounts shall be operated jointly by the chairman of the trust and treasurer of the trust

(ii)

The trust may open Bank Account/s in the name of institution/organization founded by the Trust. Such Bank Accounts shall be operated by such persons as authorized by the board of Trustees from time to time.

# 17. APPLICATION OF THE PROPERTIES OF THE TRUST

# 19. DEFECTS OF PROCEDURE IMMATERIAL

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

#### 20. AMENDMENTS

Any amendments to the Trust Deed shall be made only after approval of the majority of the Board of Trustees along with prior permission from income tax commissioner / any other law as may be applicable for the time being.

#### 21. MISCELLANEOUS

i) There is no Other immovable ,movable assets as on date of registration.

### 22. DISSOLUTION

In the event of dissolution of winding up of the Trust the assets of the trust remaining on the date of dissolution shall under no circumstance be distributed among the Trustees, but the same shall transferred to other Trust, Society, Association or Institution whose objects are similar to those of this Trust.
